1. Personnel

a. Losses are as follows:

- (1) 4 Marine Officers transferred for duty.
- (2) 168 Marine enlisted transferred for duty and 34 by service records by reason of medevac.
- (3) 3 USN enlisted transferred for duty and 2 transferred by service records by reason of medevac.

b. Joinings are as follows:

2. Administrative. Nothing significant.

3. Intelligence

a. Enemy activity. The enemy activity for the month of April was moderate. There were the following significant contacts made during the month.

(1) On the 17th, the O.I. in the 50 foot tower at (AI 968584) spotted three (3) VC digging on Highway 14 at (AI 957536). A squad from Company C was sent to the area and an AC was called on station. The O.I. in the 50 foot tower observed ten (10) VC moving from north to south across Highway 14 and fired 10 rounds small arms resulting in two (2) VC M.I. (Conf). A Sparrow Hawk was requested and landed at (AI 955575). The Sparrow Hawk pursued the enemy but was unable to reestablish contact. A VC youth was apprehended on Highway 14 and through interrogation it was learned that he had been instructed by the VC to dig holes in the road. The VC youth was sent to III MAF as a P.I.

(2) On the 25th, a County Fair was conducted in Co. VII (1) and (2) hamlets resulting in the destruction of the infrastructure and 80% of the VC military structure. The VC autonomous Chief, the Hamlet Tax Collector, the Autonomous Village Chief and one guerrilla were captured. There were seven (7) VC M.I. (Conf). Of these M.I.'s, one was identified as NGUYEN THUC, a VC demolition expert who had been placing mines on Highway 14 and Liberty Road North. NGUYEN THUC had received demolition training in the mountains. He was identified as NGUYEN CHAI the VC Autonomous Hamlet Chief of Co. VII and

PART II: NARRATIVE SUMMARY

From 1 April until 12 April, the Battalion was responsible for the Eastern Sector of the 9th Marines FACR. During the remainder of the reporting period, the Battalion was responsible to the 7th Marines for this same sector. This responsibility included the occupation and defense of the assigned sector from enemy attack, execution of offensive operations in the assigned sector, maintaining the Main Supply Route open to traffic, establishment and maintenance of a reconnaissance network in the assigned sector, and the support of pacification programs as directed. One County Fair was conducted during the reporting period lasting approximately 72 hours. Companies B and C loaned CpCom to other units on several occasions as indicated in paragraph 5 (Special Operations). Enemy activity consisted mainly of sniper action and booby trapping. Friendly activity consisted of day-light contact and reconnaissance patrols and night ambushes. On 4 April 1967, C-1 was visited by LtGen ADE and MajGen NICKERSON. MajGen NICKERSON, LtGen ERKINE (Rgt) and LtGen WILL visited 1/26 County Fair site on 26 April 1967 and LtGen WILL again visited the County Fair site on 27 April 1967. C-1 was visited by LtGen WILL and Mr. DOVOLE, editor in chief of THE BULLET on 27 April 1967.

During the month of April, 1769 military and civilian vehicles traveled the supply route, with security being furnished from this Battalion. The majority of these vehicles were in route to the AMCOM Industrial Complex.

VC KIA (P). Friendly casualties were 5 KIA and 8 WIA. County Fair 2-66 was held 25-28 April as directed by Frag Order 113(A)-67 in CAM VAN at (AT 965597). A total of 529 Vietnamese civilians were screened resulting in 7 VC KIA and 5 PW. There were no friendly casualties.

Co A at 282100H provided one Company (-) (Rein) as blocking and sweep forces as directed in Frag Order 116(A)-67. The operation resulted in 5 VC KIA (C), 1 ARVN WIA, and no Marine casualties. This command distributed 48,277 general and special purpose leaflets within the TAOR. They were disseminated in populated areas and along suspected routes of VC movement. The battalion received support from the 244th PsyOps Co, USA, on several occasions. Activities consisted of ground loudspeaker broadcasts and audio-visual presentations during Operation GOLDEN FLEECE, County Fairs and on other occasions in general support of the PsyOps program. The 5th ACS, USAF provided extensive support by aerial leaflet drops and loudspeaker broadcasts on general themes. During the month of April primary emphasis was placed on CHIEU HOI themes and the Revolutionary Development program.

The six Kit Carson Scouts assigned to this command have been employed daily in support of Battalion operations at the squad and platoon level. They participated in patrols as trail guides, in gathering intelligence from civilians and in psychological operations. Their ability to communicate with the local populace and knowledge of VC tactics has made a material contribution to progress of battalion operations. The Scouts have conducted classes for the Marines on VC tactics and trail signs and have provided a significant amount of intelligence on local VC activities. Efforts to remove the language barrier have made definite progress. The Scouts and Marines

 NGUYEN HUAN, a guerrilla squad leader. All three VC KIA's identified appeared on the Battalion Black List.

(3) On the 28th, CAC C-2, while providing security for VC civilians harvesting corn at (AF 96255A) forced three (3) VC, with weapons, out of the cornfield. One (1) VC was captured and through interrogation it was learned that he was a member of the B-20 Battalion. There were 54 small arms incidents and 25 mine/booby trap incidents during the month.

b. Weather. April weather was typical of the dry season. Cross country movement for infantry and tracked vehicles was unimpaired. All lines of communication were open to wheeled vehicles. A synopsis of the weather for April follows.

4. Training. On the job training was conducted for all MOS's and the five day indoctrination period for newly arrived personnel was lengthened to seven days. In addition, advance training conducted for newly arrived officers and NCO's in supporting arms and demolitions was continued. The newly instigated training program met with encouraging results.

5. Special Operations. Operation GOLDEN FLEECE held 6-15 April a total of 2946 Vietnamese civilians were screened resulting in 9 VC KIA (C) and 10

are now able to converse well enough on patrols that the shortage of interpreters is no longer a major problem. One Kit Carson Scout was killed on 27 April 1967 as a direct result of combat operations against enemy forces.

6. NBC Defense. A revised NBC Defense SOP was drafted and will be published early next month.

7. Command and Control. The Battalion was commended by LtCol D. E. NEWTON throughout the reporting period. 1st Battalion, 26th Marines remained AdCon 3rd Marine Division and OpCon 9th Marine Regiment until 120900H April 1967 at which time 1st Battalion, 26th Marines shifted to OpCon 7th Marine Regiment.

8. Communications and Electronics. Nothing significant.

9. Close Combat. Nothing significant.

10. Fire Support and Fire Support Coordination. During April, artillery fired on targets of opportunity, fired zone fires on suspected enemy positions, harassment and interdiction fires and registration missions. Both offensive and defensive on-call fires were utilized during the reporting period.

Artillery fired 111 missions against a known enemy during April. Casualties resulting from artillery were reported to be 5 KIA (G) and 31 KIA (P). Confirmed figures might have been higher, but conditions in many cases precluded an immediate search of the target area. Surveillance by FO's indicated that artillery was both effective and accurate.

Two 81mm Mortar sections were attached to outlying rifle companies while the other two sections were kept on Hill 55, one on Hill 55 proper and the other on Hill 55, Finger #1 in a general support role. Mortar H&I's, observed and unobserved fire missions were fired during April.

11. Logistics. During this reporting period the companies were supplied 194,500 lbs of supplies. In addition to these supplies, two hot meals and cartoned milk were supplied to each company each day. Organic vehicles traveled 32,060 miles in support of the Battalion. Supporting M52A2 trucks traveled 1,905 miles in resupplying the companies.

Cantonment developments for the reporting period include thirty (30) 8 X 10 living bunkers, one storage shed and four heads.

Certain motor transport parts and bunker material remain critical.

12. Air Defense. Nothing significant.

13. Combat Air Support. During the month of April the command successfully coordinated and controlled 38 day and 10 night helicopter medevacs. The battalion air section coordinated three airstrikes during the month. Two of these were in direct support of engaged friendly units and one was controlled by the battalion ground F.C. All air delivered ordnance was used with good effect, resulting in 6 structures destroyed and 8 VC KIA (P).

14. Medical and Dental. During the month, 4 corpsmen were transferred to other commands for duty and 2 corpsmen were evacuated out of country due to hostile action. One new E-7, two E-6's, one E-4 and three new E-3's were received on board for duty. During April 2 corpsmen were WIA's with one being evacuated out of country, and one being treated and held aboard the USS SANCTUARY. At the present time medical personnel census stands at 2 Officers, and 53 enlisted personnel. During the month, 9th Marines BAS, which had been combined with the 1/26 BAS, was moved out of our TAOR. There were no ground improvements made during the month. Combat casualties treated at BAS during April were 2 KIA's, and 42 WIA's with 17 being treated and returned to full duty, and 25 treated and held at BAS or evacuated for further treatment. Average patient census at BAS for the month was 8. During April, 943 Marines were treated at 1/26 BAS and 60 VN treated at our local MEDCAM tent. One County Fair was held during April lasting three days, with 600 VN being seen and treated. The Dental facility treated 125 Marines of this command and 30 civilians.

15. Chaplain and Moral Welfare. Protestant coverage given by Battalion Chaplain. Protestant services held in 1/26 CP Sunday morning and evenings, and Wednesday evenings; in Co C CP Sunday morning; in Co A positions Sunday afternoons; and in other line companies on weekdays. Bn Chaplain normally spent one night weekly in the field with Co B. Total Protestant services held in Battalion were 25, attended by 579 Marines. Six Bible classes were held in 1/26 CP, attended by 37 Marines. Bn Chaplain gave Chaplain's orientation lecture and a lecture of Vietnamese Religions and Customs to 67 replacement troops, counseled 37 Marines, visited patients in BAS daily, made 45 visits to 1st Med Bn and NSA Hospital, made 8 visits to prisoners confined in the Brig, wrote eight pastoral letters to MCK of deceased personnel, handled six cases with AmCross, and distributed over 2,000 New Testaments and religious pamphlets. Bn Chaplain maintained liaison with American Protestant missionaries in DaNang.

Until 11 April, Roman Catholic coverage was provided for 1/26 by the Regimental Chaplain, 9th Marines, with Mass in 1/26 Co Sunday morning, and in line companies on weekends when possible. Since 12 April, Mass has been provided for 1/26 Co Sunday afternoons by Regimental Chaplain, 1st Marines; however, there has been no Roman Catholic Mass for the line companies.

Until 11 April, Bn Chaplain provided Protestant coverage to 2/12 Co, B/1/11, CAP 1-1, CAP 1-2, and CAP 1-3, conducting four services attended by 53 men.

Bn Chaplain was out of country on R&R 12-19 April.

16. Civic Action. During the month of April the Civil Affairs Officer initiated a market project which will be built near Hill 55 (AT 9561). A public primary school in the CAP resettlement Hamlet of AI DONG (AT 923562) was completed and a dedication ceremony is planned for early May. Approximately 50-60 children will benefit from this school.

Fertilizer from the GVN was distributed to the villagers of THANH SON Village, DIEN BAN District. Each villager paid 220\$VN per bag.

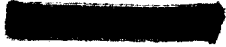
One County Fair was held during April, for the people of CAM VAN (1) and (2) Hamlet, DIEN BAN District. The operation allowed this office contact with approximately 529 villagers.

Plans were begun this month for the commencement of the 4T clubs in association with the agricultural assistance team from the 29th CA Co. It is planned that one of these clubs will be begun at each of the schools.

During April the refugees from the DAI LOC Refugee Center, QUANG NAM Province, gave a party for all of the Marines at the CAP C-2 at TRUNG AN (AT 9458). During the course of the meal speeches were made by elders, thanking the Marines for all they are doing at this resettlement Hamlet.

Overall attitude of the villagers in this area is greatly improving. Their interest in new projects, is greatly facilitating the above achievements.

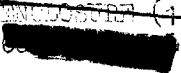

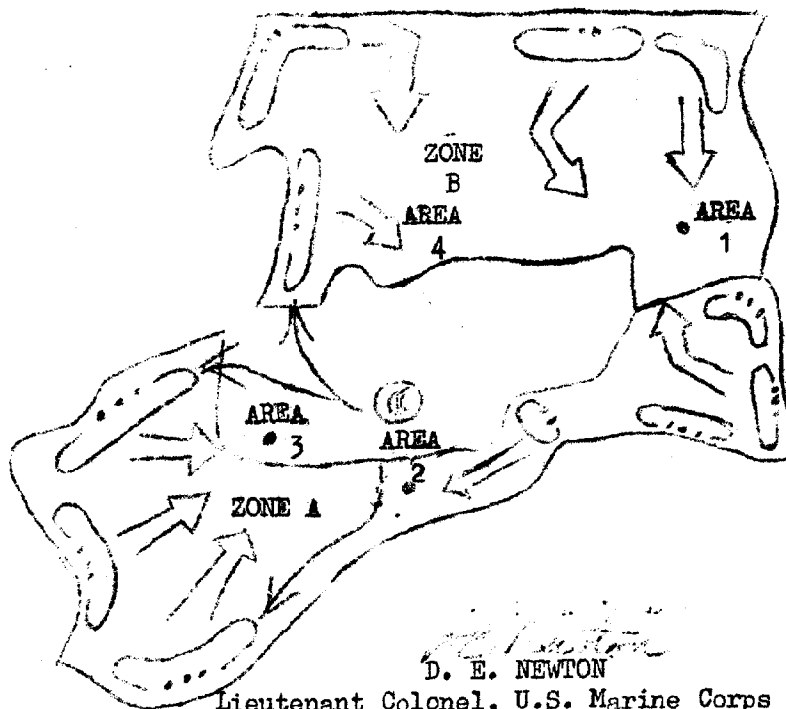

A further and more complete evaluation of the effect on the infrastructure should be apparent after thorough interrogation of the PW's and completion of operations in the hamlet. There is a possibility of a real breakthrough as far as opening up hamlets south of the SONG LO THO River for Civic Action.

4. Objective.

a. To locate, capture, or destroy enemy forces and conduct Civic Action/Psychological operations, and to further the Pacification Program and assist in Revolutionary Development.

b. Commander's Analysis. The County Fair conducted at CAM VAN was singularly successful in accomplishing its missions; (1) that of destroying VC and (2) that of indoctrination of the population. The latter mission was considerably complemented by the success of the former. It has become apparent by conversations with the village elders that the Viet Cong are not wanted. That the VC hamlet chief was killed and the VC village chief was captured, greatly pleased the people, and it is therefore anticipated that these villagers will eventually prove strong supporters of the GVN.

5. Friendly Casualties. None.

6. 529 VC screened.

7. VC Losses. 7 KIA, 5 PW.

8. Effect on Infrastructure. The infrastructures of both CAM VAN (H) and XI QUANG (V) have been severely damaged. The VC village chief, the tax collector and two lesser cadre were captured and the VC hamlet chief was killed.

Additionally, the military structure, upon which the infrastructure bases its control of the people, was 80% destroyed. The people expressed dissatisfaction with the VC when interviewed on the first day of the County Fair. Prior to the termination of the County Fair the people were reinterviewed. The general attitude was one of acceptance of GVN control.

As VC KIA's were brought from the cordon area, the people seemed to become more and more relieved and as the Fair progressed, considerable headway was made. The people went home with some understanding and explanation of who and what a Marine is - and how they can work with the people in achieving a victory.
